Who Can be Nominated for the Award?

Anybody who is involved in Square Dancing, Round Dancing, or Clogging in the province of New Brunswick may be nominated (singles or couples). Anybody who was previously nominated and did not receive the award may be re-nominated. Nominee must be member(s) in good standing with the Federation of Dance Clubs of New Brunswick, Inc. (FDCNB)

Who Can Nominate Someone for the Award?

Any New Brunswick dancer, caller, cuer, club or association can nominate someone for the Distinguished Service Award. Currently serving members of the Federation Board of Directors may not submit a nomination. Nominator(s) must be a member in good standing with the FDCNB.

What should be considered when making a nomination?

If you wish to nominate someone for the Distinguished Service Award, you should look at the following list of items. This list has been developed to help you in writing the nomination. It is not necessary for the nominee to have done all of these things, but they should have done something that could be considered special (it doesn't have to be on the list). Consider what the nominee has done that others have not.

Points to Consider

As Dancers

- What did they do within their club?
 - o Did they hold a position (secretary/treasurer/president/caller/cuer) in their club?
 - o Did they do anything outside the ordinary to promote dancing within their club?
 - o Were they good-will ambassadors for Square & Round dancing?
 - o Did they do something to get new dancers involved?
 - o Did they support other clubs? (promote and attend their dances, etc.)
- Were they active members of their local Association?
 - o Did they hold a position in the Association?
 - o Did they support other Associations' special dances?
- Were they involved with the Federation of Dance Clubs of NB?
- Have they had any involvement with the Canadian Square and Round Dance Society (CSRDS)?
- What special events were they involved in? (Convention 2002? 2010? 2022?, MCCA?, Planning special Square/Round Dances, arranging busses to other club dances, advertising, developing flyers, volunteering, etc.)

As Callers or Cuers

- Did they work to promote Square or Round dance?
- Did they do something for square/round dance without being paid?
- Did they support other callers/cuers/associations' special dances?
- Were they good-will ambassadors for Square & Round dancing?
 - o Did they put on demonstrations for prospective dancers?
 - o Did they donate their time in support of special dances?
 - o Were they willing to go outside their own area to help a community form a club?
 - o Did they work to bring notice to Square/Round dance in their area?
- Were they actively involved in the callers/cuers associations?
- What special events have they been involved in?(Convention 2002? MCCA?
